- On June 5, 2020, the U.S. Fish and Wildlife Service (Service) announced the publication of a <u>draft environmental impact statement (EIS)</u> and <u>draft rule</u> inviting <u>public comment</u> on proposed management of conflicts associated with <u>double-crested cormorants</u>.

The U.S. Fish and Wildlife (Service) is reviewing a permit application for the incidental take of golden eagles (*Aquila chrysaetos*) at the Red Horse Wind 2 Energy Facility, approximately 15 miles west of the city of Willcox, Arizona. We are requesting your views, comments, or concerns regarding the proposed permit authorizing incidental take of golden eagles at the Red Horse Wind 2 Energy Facility.
